## Treasurer's Report – Debbie Bray

- Distributed treasurer's report showing checkbook balance of \$10,373
- Distributed report of anticipated years end expenses and balance
  - Last 3 years CWGA ended the year with a checking balance of approximately \$5,000
- Should have received \$1000 from men's club and received a check for \$750. Laura Curran to discuss with the men's club

# Handicap/ Scoring / Day's Play – Diane Meyers

- 54 of our 104 members qualified for club championship and most improved golfer
- Most improved golfer will be determined by GHIN and announced at Stagette
- We are averaging about 50 players a week in league play (including 18- and 9-hole players)
- There are lower payouts as a result of fewer players
- September 29<sup>th</sup>, both the 9- and 18-hole group will play the same course as they will be aerating one course. 9-hole group will play following the 18-hole group
- Janet Ferguson mentioned that members would like to see all scores and Diane stated that is actually easier for her team and will happily change back to showing all
