- Discussion took place took place as whether or not members who do not list Charbonneau as their Home course should pay two GHIN fees so that tracking can be done more easily for qualification for the championship tournament.

than their Away course, check with Kelly at OGA to see if she has suggestions on how to make

The exception to the rule is any Best Ball Tournament

 LEAF RULE; At certain times of the year, ground may be covered by loose impediments, such as leaves, seeds, or corns which may make it difficult for player to find or play their ball. These areas of loose impediments in the general area or in a bunker are determined ground under repair from which free relief is allowed under Rule 16.1 including a free drop.

Under Penalty Areas sentences:

Players may use dropping zone on any scheduled CWGA Day's Play or Tournaments. Dropping zones are defined as: **A.** A circle or square painted with white paint

B. In the absence of a painted dropping zone, an area defined by CWGA Local Rule to be a dropping area no more than two (2) club lengths from the red stake which is most lateral and closest to the general area immediately to the left or right of the water penalty area.
