Co-President, Lynne McMaster welcomed members to the October Luncheon and General Meeting and called the meeting to order at 1:30 PM.

Amy Day announced the nominations for the 2026 elected officers.

Amy asked members for a voice vote to elect officers for the 2026 CWGA season. The voice vote was unanimously in favor.

A ballot was passed out for attending members to amend the By Laws that eliminates the number of years an officer can run for an elected member of the Board. Secretary, Patti Book collected and counted the ballots. We had 76 members at the luncheon.

71 ballots were signed and returned.

69 members voted yes for the By Laws change.

2 members turned in a signed ballot but did not vote yes or no.

5 members who attended lunch did not turn in a ballot.

90% of members attending voted affirmative for the proposed By Laws change. The amended By Laws passed.

Cathi McLain announced the need for volunteers to help with the Festival of Arts on October 17, 18, 19. Please contact Jan Landis or Linda Peck if you can volunteer any time for this event.

Debbie Bray gave a synopsis of the end of year finances. The Scholarship Fund has \$857 that is donations from members. If the \$100 Hole in One budget does not get used the month of October, those funds will be added to the Scholarship Fund. We will carry over \$4000 to next year.

Rita Albrich shared how funds were used to pay winners from Eclectic. The decision was to pay 1/3 of the field which means that 9 players in four flights received equal amounts. In flight 1, 13 players were paid \$7 each because there were many ties. In flight 2, 3 and 4, 9 players in each flight received \$8 each. Rita encouraged anyone who may not like the way payouts were decided to volunteer and to take over the Eclectic. We are looking for someone to Chair Eclectic.
