Highlights of OGA President and CEO Report

- New logo for OGA (see new logo above)
- Updated website that is more user friendly
- 52,000 adult members, 5,000 Junior members
2500 new members in the past 2 years
- 1.1 million rounds of golf in 2025
 - 9 hole courses growing in Oregon
 - 76% Public courses and 24% private courses
- Junior Golf: 5,000 members with 25,000 rounds subsidized
- 10, 000 volunteers (Junior Golf, Tournaments, course raters, handicap coordinators)
- 35 courses rated in 2025
- License plates to be distributed April 2026
- Developing Value to Member Clubs through Member Planet web platform (tracks members, finances, GHIN), Golf Genius, USGA (OGA pays for clubs use of Golf Genius)
- OGA finances stable even though costs continue to rise (staff, OGA course maintenance...)
(No OGA fee rise for 2026 (\$41)
(OGA course new irrigation system complete. There were 37,500 rounds at the OGA course in 2025)
- Continued access to Columbia Sportswear and Adidas stores

Evans Scholars Foundation REPORT

-25 current Evans Scholars from 54 clubs and courses across the state. The Evans Scholars graduated 2024 at a 98% rate and compiled a 3.3 cumulative GPA.-39 with full scholarships (35 living in sponsored University of Oregon House)

During the past 2 years a research group conducted an inclusive Oregon Golf Impact Study

The Oregon Golf Economic Impact Study Reported:

- \$2.4 Billion Total Economic Impact
- \$1.6 Billion Direct Economic Impact
- \$18,000 Total Jobs Supported
- \$252 Million Local Taxes

- Oregon's golf economy is supported by 172 golf facilities and nearly 2,950 holes that collectively serve over 390,000 golfers across the state, including nearby Vancouver Washington. Within this base of participants are 85,000 avid golfers who each play 25 or more rounds annually, forming a stable core of year-round demand. These golfers together with a vibrant visitor's market, sustain a wide variety of facilities ranging from municipal courses and community related clubs to world renowned destinations.

- Oregon's Flagship courses include Bandon Dunes Golf Resort, Sunriver, Pronghorn and Tetherow are global attractions.

"This Oregon Golf Economic Impact report provides a detailed analysis of Oregon's golf industry, measuring its impact across facilities, tourism, retail, and related business sectors. By capturing both the direct and ripple effects of spending, the study highlights golf's role as an anchor of the state's outdoor recreation economy, an industry that supports local communities, attracts national attention, and showcases Oregon as a world-class golf destination."
