The meeting was called to order and attendees were welcomed by Co-President, Sue Schneider at 9:00 AM. Sue shared that the new Executive Committee has already met twice to plan for the 2026 season. Our CWGA is governed by our By-Laws. This year our leadership will be guided by the Core Values of Integrity, Respect, Stewardship, Mindfulness (attached).

Minutes –

The November 5, 2025 minutes were distributed via email and posted to the website. There were no corrections or additions. Motion was made and seconded, and the November 2025 Board minutes were approved.

Treasurer's Report – Debbie Bray

- The 2025 season ended with a balance of \$4596.61 on 11/17/25.
- The current Checking Account balance is \$22,805.26.
- Outstanding expenses are estimated at 0.
- Currently have 131 members for 2026. All but 3 of those applications came in before the end of 2025 to take advantage of the \$20 savings.
- A proposed budget is ready for discussion and approval. Projected carry-over balance of \$2849.61 for the 2026 season.

Committee Reports

CWGA Director for CGC BOD – Karen Miller

- There has not been a meeting so nothing to report except that the grounds staff are continuing to clean up the course following the last wind storm.

Membership – Mary Jane Hunt

- One member is returning after a year and there are 10 new members, several from the Lake Oswego group who played at Charbonneau the last few years while the LO course was under construction. New Member Orientation will be March 31st. The Membership Committee is currently updating the PowerPoint presentation.
- Winter Luncheon dates have been set for January, February, and March. The goal is to create a casual event for members to get to know each other.
- January 15 luncheon will be catered by The Market Café featuring pizza, salad, and cheesecake, as it is National Pizza Week. Members are encouraged to wear their favorite hat since Thursday is National Hat Day. Final luncheon signup reminder will go out Friday.
- February 19 “National Chocolate Mint Day” luncheon will be catered by Butteville Store.
- March 19 “Show & Tell” luncheon will be catered by Cheryl’s on 12th, As Good As It Gets.

Handicap – Diane Meyers

- Diane thanked CWGA for the Al's gift card given in recognition for her outstanding work and dedication for CWGA.

- Diane is working with Sue Oberg and Chris Bensel to re-rank the handicap of holes according to level of difficulty.
- Diane has set a goal to teach players how to compute "Most likely score". (This was an issue in last year's partner tournament).

Day's Play/Scoring –Patti Book

Winter Golf:

- We have 64 members signed up for winter golf.
- Members may bring a guest and request who they would like in their foursome.
- Six days were played in November with a total of 104 players signed up to play. There were 54 members signed up to play during the 5 scheduled days in December. Tee times were not booked for the holiday weeks.

2026 Season

- All 12 managers and helpers from the 2025 Day's Play are returning to schedule and score the 2026 season.
- A luncheon was held for the past volunteers to celebrate and review the 2025 season.
- The focus for 2026 is on Communication. Managers will share a tidbit of information at each general meeting.
- On Thursdays, Golf Genius selects the pairing. It is a random pairing and not based on A, B, C, and D players in foursome.
- Payout for scrambles will be funded from the \$5 entry fee.
- There will not be ties in competition rounds.
- Joann Linville suggested that at each scramble a hard copy of "Rules for the Days Play" be attached to the scorecards.

Rules – Joann Linville

- OGA Rules class is scheduled on February 10-19, 2026. Twelve 2-hour virtual sessions will be held over 6 weeks. She has the information if anyone is interested.
- We have several new trees that are staked on the course. Chris Bensel has asked that we review the rules of play near the staked trees.
- Joann needs an assistant or co-chair for this committee to help with issues at competitions and days play. Diane Meyers is interested; however, she is unable to attend this year's OGA training. Sue Schneider has the last version of the *USGA Official Guide to the Rules of Golf* (2019) and will give it to Diane.

CGC Green and Golf Liaison – Rose Mason/Coleen Larson

- No meetings the last few months.
- Volunteers and the staff are continuing to clean the course after the storm.
- Bill Shevlin is stepping down from the leadership of this committee.

Old Business

- **Sunshine** will be discontinued. It is a concern that this is hit and miss at times, leaving someone out because we do not have the information. The suggestion was made that we each be our own Sunshine Committee.
- **Eclectic:** Linda Peck has volunteered to chair.
